## **Prof. Spyridon Flogaitis**

Prof. Flogaitis has an extensive and comprehensive education. He studied Law at the University of Athens and graduated in 1973. He continued his studies at the University of Paris 2 – (Sorbonne) in France, graduating with a Diplôme d'Etudes Supérieures en droit public. In 1978, Prof. Flogaitis got a PhD at the University of Paris 2 (Sorbonne).

Prof. Flogaitis began his academic career in 1980 at the Law Faculty of the University of Athens as assistant. He was elected Senior Lecturer in 1982, Associate Professor in 1985 and full Professor in 1992. Currently Prof, Flogaitis teaches Administrative Law and Comparative Public Law. He has taught as Visiting Professor in various European universities throughout his career.

Since 1974, Prof. flogaitis is an attorney-at-law, including at the Supreme Court and the Council of State since 1985. He is a Senior Partner at the law firm “Flogaitis – Pamboukis – Sioutis & Associates” since 1990. Prof, Flogaitis has served as member or president in several committees: (Committee for the Competences of Local Government, (president), Committee for the Codification of the Hellenic Environmental Law, Committee for the Codification of the Hellenic Law of Public Works, Committee for the codification of the administrative procedure. Currently, he’s the Director of the European Public Law Organization (EPLO).

Since 2000 and up to 2009, Prof. Flogaitis was a member of the United Nations Administrative Tribunal. Prof. Flogaitis also served as: Honorary Fellow, Wolfson College, University of Cambridge, Academic Bencher of the Inner Temple, London, President, Administrative Tribunal, EBRD, Vice-President, Appeals Board, European Space Agency, Member, Appeals Board, EUMETSAT, Member, Appeals Board, European Centre for Medium-Range Weather Forecasts, Former President, United Nations Administrative Tribunal, Former Vice-President, Organization of Intellectual Property, Former Judge, Supreme Court of Article 88.2 of the Constitution, Greece, Former Arthur Goodhart Professor, Faculty of Law, Cambridge University, Former Yorke Distinguished Visiting Fellow, Faculty of Law, Cambridge University, Former Chair of the Joint Appeals Board at IFAD, UN, Minister of Interior, Hellenic Republic (August-September 2009), Minister of Interior, Hellenic Republic (August-September 2007 and as Alternate Minister of Foreign Affairs, Hellenic Republic (August-Sept. 2015).

He has participated in numerous international seminars and conferences on administrative law and he has published a great number of articles. He is author of the books: Administrative Law (co-author), Public Contracts, Cases and Materials in Administrative Law, The Greek Administrative System, Administrative Law et Droit Administratif, Contemporary aspects of state interventionism, Fundamental concepts of administrative organization, Système vénitien de successions ab intestat et structures familiales dans les îles ioniennes, La notion de décentralisation en France, en Allemagne et en Italie etc. He is co-editor of the reviews “Environment and Law”, “Energy and Law”, “Critical review of legal theory and practice” and “European Review of Public Law”. Prof. Flogaitis holds the Chevalier de la Legion d’Honneur, Republic of France, the Cavaliere dell’Ordine di Merito della Repubblica Italiana, the Officer’s cross of the Order of Merit of Hungary and the Grande-Oficial da Ordem do Infante D. Henrique, Portuguese Republic.
