Corporate Finance (4 ECTS)

In Corporate Finance, students will learn how to read, evaluate and analyze financial statements and how to use these statements to measure the health, profitability, and other important indicators of a company. Students will gain a deeper understanding of the connection between corporate finance, financial markets, and the economy.

Corporate Valuation (4 ECTS)

The course aims at providing students with the conceptual and theoretical framework surrounding valuation issues and the practical tools to address such topics in real-life situations. The course concentrates on the most widespread methodologies to carry out corporate valuation based on income, cash flows and comparables.

Marketing Management (4 ECTS)

In this course, students will be able to develop a broad understanding of the core marketing concepts and their practical application. Students will examine key marketing principles and their relationship with the business environment, make decisions in the marketing field, and gain a practical marketing approach just as it occurs in real companies.

What will you gain after attending LSB Summer School Program?
