ABOUT US

Caucasus University's Economics PhD program is designed for economists and researchers seeking to enhance their analytical skills and acquire an advanced academic degree. Consisting of 180 ECTS, the program takes students through key field courses in economics, as well as research design, pedagogy and scientific writing classes. Students should be able to complete the program in 3 years while maintaining full-time employment.

The program is taught in English by Western-trained PhD economists, providing an excellent pathway to gainful employment in academia as well as in research, macroeconomic regulation, and economic policy design positions with national and commercial banks, government ministries, think tanks and international organizations. Successful graduates will be awarded a PhD degree in Economics.

Admission requirements & process:

Applicants must have at least a Master's degree from an accredited educational program. Admission is granted based on:

Three years, including one year of classes and two years of dissertation research. Students may take up to four years to complete all program requirements and defend their thesis.
