The Caucasus School of Law started operating in 2005. The School offers Anglo-Saxon model of education, well adapted to the Georgian reality. - Unconscionable Contracts – execution and restitution in German, and Anglo-American Court Practice (comparative analysis with Georgian Law)
- USA and German Corporate Law (comparative analysis with Georgian Law)
- Property Law from Anglo-American and German perspective
- Private International Law and International procurements
- International Tax Law
