გიგა აბუსერიძე არის კავკასიის უნივერსიტეტის სამართლის სკოლის აფილირებული ასოცირებული პროფესორი და თბილისის სახელმწიფო უნივერსიტეტის მოწვეული ლექტორი. ფლობს სამართლის დოქტორის აკადემიურ ხარისხს (რიგის სტრადინშის უნივერსიტეტი / Rīga Stradiņš University). 2022–2025 წლებში იყო ლატვიის მეცნიერების საბჭოს (Latvian Council of Science) ექსპერტი, ხოლო 2015–2022 წლებში მუშაობდა რიგის სტრადინშის უნივერსიტეტის იურიდიული ფაკულტეტის პროექტების განვითარებისა და კვლევების ლაბორატორიაში მკვლევრად და ლექტორად. იგი ასევე არის ქართული და საერთაშორისო რეფერირებადი (Scopus, WoS) აკადემიური ჟურნალების სარედაქციო კოლეგიის წევრი, მრავალი სამეცნიერო სტატიის ავტორი და საერთაშორისო კვლევითი პროექტების მონაწილე. მისი კვლევის ინტერესები მოიცავს სამართალსა და დიპლომატიას, საერთაშორისო სავაჭრო და ბიზნეს სამართალს, თავისუფალი ვაჭრობის სამართლებრივ რეჟიმებს და ეკონომიკურ დიპლომატიას.
