<b>Program structure and credits</b>

The program comprises 60 ECTS credits spread over 2 semesters, with each semester comprising 30 ECTS credits.

Accordingly, the estimated duration of the Georgian Language Preparation Educational Program is 1 year. The academic year is built on a semester principle. The semester includes a combination of study weeks, a

period of additional examinations, and a period of student performance assessment in additional examinations. An academic year is a combination of semesters, including vacation periods. 1 ECTS credit is equal to 25 hours, which includes both the contact time/class-time (lecture, seminar, practicum, etc.) and student's independent work (hours spent to prepare for the midterm and final assessment, as well as homework and presentation(s)).

After the expiration of the period of the Georgian Language Preparation Educational Program, a student with academic debt has the right to continue his / her studies with a view to completing the program in additional semesters (not more than 4 semesters) and maintain the student status.

30 ECTS credits of the Georgian Language Preparation Educational Program in the first semester, will be dedicated to equalizing the different levels of language competencies (writing, reading, listening, speaking) for the unified compulsory course of the second semester, for which students will be divided according to the initial language competencies (determined by pre-test results – written pretest, while listening-speaking competencies are determined by audiotext and oral interview) in the A and B block groups.

Within the second semester, 20 ECTS credits are allocated for the unified compulsory Georgian language course. In addition, the program includes a mandatory component of intercultural education (5 credits) presented in the course: "Tolerance and a Diverse World". Caucasus University was involved in this project (Prof. Mariam Manjgaladze participated) and officially became a member of the inter-university network (representatives of the university also participated in the development of sectoral characteristics) within the framework of the OSCE OECD project "Preparing Georgia for Youth Diversity and Tolerance".

In the same semester students will take 5 ECTS credits in compulsory-elective field module in 4 areas (Humanities and Sociology; Business and Technology; Public Administration; Medicine and Health) and 6 sub-fields (Field Language - Humanities; Field Language - Education, Social Sciences and Education). Media and Cinema Language; Industry Language - Technologies; Industry Language - Business, Economics, Tourism; Industry Language - Law, International Relations and Public Administration; Industry Language - Medicine and Health). The elective courses are designed with students' future professional choices in mind and include teaching the terminology, field vocabulary, and language constructs that are specific to one field or another (in fact, the choice covers all the dimensions of the schools at Caucasus University).

To support the students in learning Georgian, to develop practical skills in field specifics, to improve intercultural relations and rediscover skills (other languages, cultures, new people or new areas of knowledge), students will have the opportunity to do field internships at partner schools of Caucasus University.

### **Program Admission Preconditions**

Applicants have the right to study in the Georgian Language Preparation Educational Program based on the results of the Unified National Examinations General Capacity tests in Azerbaijani, Armenian, Abkhazian and Ossetian languages, while Georgian and Abkhazian-speaking Georgian entrants are eligible only on the basis of Abkhazian or Ossetian language test results. Teaching is conducted only in Georgian.

Unified National Examinations are provided by a legal entity under public law - the National Examinations Center. Exceptions to the general rule of enrollment in a higher education institution shall be allowed only in cases prescribed by law.

Enrollment in the program through mobility is possible in accordance with the rules established by the

legislation of Georgia. If a student wishes to transfer from another higher education institution to the Caucasus School of Education, the issue will be considered and the final decision will be made by the Director of Educational Programs and the Dean of the School.

Prerequisite for admission to the program is to pass the minimum competency threshold of the Unified National Examinations General Capacity Test taken in the native language.

## Description of the Program

<p><b>Program Objective</b></p>	<p>The mission of the <b>Georgian Language Preparation Educational Program</b> of Caucasus School of Education is to ensure the competitiveness of non-Georgian language school graduates by creating equal starting conditions for learning the Georgian language and allowing them to pursue their education in higher education institutions; Putting the students on a level playing field with other entrants to ensure their further success, realization of their intellectual potential and allowing them to live a dignified life in future. The mission of the program is developed in accordance with the mission and strategic plan of Caucasus University.</p> <p>According to the mission, the aim of the <b>Georgian Language Preparation Educational Program</b> is to ensure mandatory minimum language competence as prescribed by the Common European Framework of Reference for Languages (CEFR), in order to allow the students to continue their education at Caucasus University undergraduate level, with any specialization; As well as an integrated bachelor's-master's program in teacher training, an integrated master's degree in veterinary medicine, or a Georgian-language education program for a certified physician / dentist.</p> <p>Mandatory acquisition of minimum language competence in Georgian language means:</p> <ul style="list-style-type: none"> <li>• Listening and understanding the lecture / oral presentation;</li> <li>• reading and understanding field literature;</li> <li>• Answering the questions asked in the auditorium (seminar, practice);</li> <li>• Completion of the given assignment in written and oral form;</li> <li>• Preparation of homework and presentation in Georgian.</li> </ul> <p>The goals of the Georgian Language Preparation Education Program are in line with the mission of Caucasus University, which is “to prepare for local and international markets, through research-oriented teaching and learning, competitive, highly-qualified, morally-grounded professionals committed to the ideals of democracy and thus satisfy society's educational needs and requirements ”</p>
<p><b>Program Learning Outcomes</b></p>	<p>After completing the Georgian Language Preparation Educational Program, the student has mastered the following competencies:</p> <p><b>Outcome 1.</b> The student has language (linguistic) competence - uses syntactic and morphological rules of lexical stock, transforms them into meaningful expressions and builds constructions according to the norms of the Georgian language (speaking, listening, writing, reading).</p> <p>1.1. Consistently uses lexical items of the state language and formulates meaningful sentences orally and in writing; Reads / learns meaningfully within the limits of his/her language competence.</p> <p>1.2. Knows the practical application of morphological and syntactic rules; Formulates logically and grammatically correct sentences.</p> <p>1.3. Distinguishes / makes difference between academic and non-academic texts and uses appropriate linguistic forms; Listens, thinks, and, conveys the message, in</p>

writing or verbally, without errors.

1.4. Can manipulate both verbal and non-verbal means - even with limited language proficiency - overcomes the existing gap (use of strategic competence).

**Outcome 2.** The student has sociolinguistic competence (speaking, listening) and selects and uses language forms according to the context (who, with whom, where, for what purpose, establishes a relationship), taking into account the rules of linguistics.

2.1. Understands the essence of the issue / problem in the material read and listened and conveys it verbally and in writing depending on the context: with whom, where, for what reason, for what purpose.

2.2. Selects and uses intonation and recognizes modality (listening component) according to someone else's intonation; consistently conveys the plot.

2.3. Without preparation, participates in the conversation and expresses his/her opinion.

**Outcome 3.** The student has discursive competence - understands the structure of oral and written text, understands and comprehends the connection between its individual parts (listening, writing, reading); Knows the general rules of discourse.

3.1. Knows writing / reading / speaking / listening strategies and formulates ideas consistently (within linguistic competence) based on information read or heard, taking into account the rules of discourse.

3.2. Listens, understands, comprehends and formulates what is being said, asks questions, clarifies what is being said, explains and substantiates his / her opinion or assumptions, summarizes and conveys them.

3.3. Defines the necessary strategies according to a specific speech act.

**Outcome 4.** The student has sociocultural competence: to orientate freely in the existing socio-cultural environment - to express opinions, argue, lead discussions and use presentation strategies (writing, reading, listening, speaking) in accordance with the standards established in Georgian society:

4.1. Uses language verbally and in writing, according to the social context.

4.2. Determines the right communication strategies using appropriate words, expressions and forms a position in compliance with existing socio-cultural and linguistic norms about the issue, environment, situation.

4.3. Selects environmentally relevant / acceptable topics; Conducts discussion and listens to and understands representatives of different social classes.

**Outcome 5.** The student has intercultural competence - is willing to live in a diverse world and express a position in accordance with ethical norms (writing, reading, listening, speaking).

5.1. Expresses his/hers position thematically, adequately and in accordance with the norms of ethics.

5.2. Knows the rules of behavior in a diverse world and is generally tolerant of different ideas and opinions.

5.3. Conducts discussions on thematic issues and, if necessary, prepares a presentation independently, using appropriate strategies.

<b>Areas of Employment</b>	Graduates of the Georgian Language Preparation Educational Program continue their education at Caucasus University.
<b>Continuation of Education</b>	Graduates of the Georgian Language Preparation Educational Program continue their studies at the undergraduate level of Caucasus University, in any specialty, as well as in an integrated bachelor's-master's degree program in teacher training, in an integrated master's degree program in veterinary medicine, and in the program of Medical Doctor /Dentistry in the Georgian language.

### Evaluation system of student's knowledge

Mastering the courses offered by the educational program assumes the active participation of students in the teaching process and is based on the principle of continuous assessment of acquired knowledge.

The purpose of the assessment is to determine the extent to which the learning outcomes defined by the course are achieved. Student assessment is multi-component and provides assessment of course objectives and learning outcomes achieved through specific and measurable criteria and rubrics. Student evaluation is based on four basic principles of evaluation: objectivity, reliability, validity, transparency.

Two types of assessment are used in student assessment: formative and summative. The purpose of formative assessment is to accurately assess student achievement. It controls the quality of learning, determines the level of student achievement in relation to the goals set in the course. Summative assessment focuses on student development. It gives student feedback on his/her achievements.

The evaluation is based on a 100-point system. The evaluation system allows:

A) Five types of positive evaluation:

Aa) (A) excellent - 91-100 points of evaluation;

Ab) (B) Very good - 81-90 points of maximum grade;

Ac) (C) Good - 71-80 points of maximum evaluation;

A.d) (D) Satisfactory - 61-70 points of maximum evaluation;

Ae) (E) sufficient - 51-60 points of maximum grade;

B) Two types of negative evaluation:

Ba) (FX) did not pass - 41-50 points of maximum grade, which means that the student needs more work to pass and is allowed to take an additional exam once by working independently;

Bb) (F) Failed - a maximum grade of 40 or less, which means that the work done by the student is not enough and he / she has to take the course again.

Credit is awarded to the student on the basis of a final grade consisting of the sum of points earned in the interim and final grades.

The points obtained in the final exam are not added to the points obtained in the additional exam.

The assessment obtained in the additional exam is the final assessment and is entered in the final assessment of the educational component of the educational program.

Assessment of the level of achievement of student learning outcomes includes interim and final assessments, for which the share of the total assessment score (100 points) in the final assessment is determined and the minimum competency threshold is set. In particular, the share of the interim evaluation out of a maximum of 100 points is 70 points, and the share of the final evaluation is - 30 points. Both forms of interim and final assessments set a minimum competency threshold. Interim assessments identify assessment components that total 70 points. For each component of the assessment, the assessment is based on pre-defined teaching objectives and task-oriented, precise, clear criteria and assessment schemes / rubrics. In the courses taken in the first year of learning (except B2 level English) the student

shall accumulate a total of at least 51% of 70 points to be eligible to take the final exam; A student is considered to have passed the final / additional exam if he / she has received at least 51% of 30 points. In other courses, a student must earn a total of at least 59% of the 70 points in the interim assessments in order to qualify for the final exam. A student is considered to have passed the final / additional exam if he / she has received at least 60% of 30 points.

The student is entitled to take an additional exam if he / she fails to pass the minimum competency threshold of the final exam. The student has the right to take an additional exam within the period specified in the academic calendar, not less than 5 days after the announcement of the final exam results.

In case of not passing the minimum competency score of 0-50 points in the final grade or in any form of assessment (intermediate / final), the student will be awarded an F-0 score.

Both oral and written tests (tests, open-ended questions, research essays, etc.) are used to assess students' knowledge. The assessment components and their share will be reflected in the syllabus of the specific course and will be communicated to the student at the beginning of the semester. Before starting the learning process, the syllabus is loaded into the electronic learning process management system.
